The Rector of Universitas Veteran Bangun Nusantara Sukoharjo on Jl. Letjend Sujono Humardani No.1, Gadingan, Jombor, Kec. Bendosari, Kabupaten Sukoharjo, acting for and on the behalf of the Universitas Veteran Bangun Nusantara Sukoharjo, herein as the FIRST PARTY.

2. Prof. Dr. H. Syaiful Bakhri, S.H., M.H.

The Rector of Universitas Muhammadiyah Jakarta on Jl. KH. Ahmad Dahlan, Ciputat, Cireundeu, Ciputat Tim., Kota Jakarta Selatan, acting for and on the behalf of the Universitas Muhammadiyah Jakarta, herein as the SECOND PARTY.

The two parties hereby agree to hold academic mutual cooperation to promote the quality of lecturers and students with the following terms/conditions:

Article 1

THE OBJECTIVES

- 1) Promoting the quality of lecturers through visiting lecturers.
- 2) Conducting joint-research with scientific writing publications.

Article 2

THE SCOPES

- 1) THE FIRST and THE SECOND PARTY, with their roles and authority as already mentioned, provide each party with the opportunities to hold visiting lectures and to conduct joint-research.
- 2) THE FIRST PARTY provides the opportunities to the SECOND PARTY to send the academic teaching staff to academic activities.

Article 3

THE FUNDING

The funding to reaching the objectives as mentioned in Article 2 of this agreement becomes the responsibilities of each party in accordance with the agreement.

Article 4

THE ACTIVITY REFERENCE

This Memorandum of Agreement (MoA) is the reference or the basis for the respective activities as stated in Article 2.

Article 5


CLOSING


