MEMORANDUM OF UNDERSTANDING

KNOW ALL MEN BY THESE PRESENTS:

This agreement entered into the 26th day of October, 2018 in the Republic of the Philippines, by and between :

The **POLYTECHNIC UNIVERSITY OF THE PHILIPPINES**, a state institution of higher learning established on October 1904, with principal office at A. Mabini Campus, Sta. Mesa, Manila, Philippines, represented herein by its President, **DR. EMANUEL C. DE GUZMAN**, herein referred as "PUP";

University of Muhammadiyah Jakarta, a state institution of higher learning established on 18th November 1955, with principal office at Jalan KH. Ahmad Dahlan, Cirendeu, Ciputat, Tangerang Selatan, Banten, Indonesia represented herein by its Vice President, **DR. ROHIMI ZAMZAM**, herein referred to as the "UMJ";

WITNESSETH THAT:

WHEREAS, in the interest of educational cooperation and in the spirit of making significant contribution to the international and intercultural education of people, the PUP and the UMJ have agreed, as they hereby agree, to form and develop a cultural and educational collaborative understanding;

WHEREAS, the parties acknowledge that such understanding will bring not only the faculty members of their respective institutions, but also the students and the people they serve closer together in their pursuit of educational ideals;

WHEREFORE, in consideration of the above premises, the parties hereby agree as follows:

1. The PUP and UMJ shall assist one another to carry forward joint research collaboration on mutually-agreed upon areas of study;
2. The PUP and UMJ shall enter into an agreement creating a program of exchange of their respective faculty members and students for instructional research and cultural purposes. The agreement covers all disciplines offered by the respective institutions;
3. The PUP and UMJ shall explore the potential of co-sponsoring international conferences and academic exchanges in areas of joint interests, the arrangements of which shall be subjected to terms and conditions as may be mutually agreed upon by the parties;
4. The PUP and UMJ shall exchange educational materials, research publications and instructional information beneficial to both parties;
5. The PUP and UMJ shall explore the possibility of offering dual or joint-degree programs subject to terms and conditions as may be mutually agreed by the parties.


The terms and conditions specified in this mutual cooperation shall be discussed and agreed upon in writing by the appropriate responsible officers of both parties prior to the initiation of any particular program or activity.

This memorandum of agreement shall take effect upon signing thereof for a period of five (5) years. All amendments to this AGREEMENT and/or termination thereof shall be made upon mutual consent.




