



## **MEMORANDUM OF UNDERSTANDING**

*between*

**UNIVERSITY OF MUHAMMADIYAH JAKARTA OF THE REPUBLIC OF INDONESIA**

*and*

**JAMIAH ISLAM SHEIKH DAUD AL-FATHANI - THAILAND**

The University of Muhammadiyah Jakarta (UMJ) of the Republic of Indonesia and Jamiah Islam Sheikh Daud Al-Fathani (JISDA), hereinafter referred to as "the Parties".

**DESIRING** to promote further the close and friendly relations existing between the Parties;

**RECOGNIZING** the need to share value of international cooperation and have agreed to further continue their common interest in promoting the mutual cooperation in the area of education and research development;

**PURSUANT TO** the prevailing laws and regulations in the respective countries;

**HAVE AGREED** as follows:

### **Article 1**

#### **OBJECTIVES**

The objectives of this Memorandum of Understanding hereinafter referred to as the "MoU" are to:

1. Provide the framework of cooperation in the field of education and exchange students and lecturers of the Parties.
2. Both parties facilitate joint programs of practical cooperation in education.
3. Promote human resources development for lecturers and students of UMJ to some universities in Jordan and vice versa.

### **Article 2**

#### **AREA OF COOPERATION**

The area of cooperation of this MoU may consist of:

1. Development and implementation of joint educational programmes.
2. Joint research efforts in the fields of mutual interest and in accordance with requirements accepted in both countries.
3. Both universities will connect one and other to tie cooperation in many fields, such as: research, exchange of scientists, teaching staff and students in accordance with requirements accepted in both countries.

4. Both parties provide the scholarship for lecturers who want to continue the study in Southern Thailand and Indonesia
5. Exchange of information concerning scientific achievements, important conferences and symposia of mutual interest, as well as arrangements concerning the celebration of anniversary dates and memorable events.
6. Jointly organized a seminar, symposium, or discussion on current Islamic and political issues.
7. Other areas as mutually agreed by the Parties.

**Article 3**  
**TECHNICAL AND FINANCIAL ARRANGEMENTS**

1. The cooperation under this Memorandum of Understanding shall be implemented by concluding specific arrangements which form an integral part of this MoU.
2. Both parties will facilitate and encourage the implementation of cooperation under this agreement.

**Article 4**  
**SETTLEMENT OF DIFFERENCES**

Any difference between the Parties concerning the interpretation and/or implementation of this MoU shall be settled amicably through consultations and negotiations.

**Article 5**  
**AMENDMENT**

This MoU can be reviewed or amended at any time by mutual consent by the Parties. Such revisions or amendments shall enter into force on such date as may be determined by the Parties and shall form an integral part of this MoU.
